Applications are invited from the eligible female candidates for the post of Accredited Social Health Activist (ASHA).

A. PERIOD OF RECEIVING APPLICATION:

The applicants may submit online application upto 27.01.2026, 11:59 PM.

B. SELECTION CRITERIA:

Memo. No. HWF/NHRM-20/206/(Part-II)1631 Dated 27.06.2012 Health & Family Welfare Department (NHRM), Govt. West Bengal.

C. ELIGIBILITY FOR BEING AN ASHA:

1. Should be married, divorced or widowed women,
2. Should be a **resident of the same service village having match with part no mentioned above** for which she will be selected. Ration Card or EPIC or Certificate of Gr-A officer in this regard is mandatory to proof residential qualification.
3. Should be within the age group of 30-40 yrs. In case of SC and ST candidates, the lower age limit is relaxed to 22 years. In both cases age of the applicant means her **age as on 01.01.2026**
4. Should be Madhyamik appeared or equivalent [from any Board / Council / University recognised / registered by central or state government]
5. Women candidate who are Madhyamik pass or possessing higher qualification, only marks obtained in Madhyamik or equivalent examination will be considered.
6. The score of Madhyamik/Equivalent Examination would be calculated without the marks obtained in the Additional/ Optional/Elective subject (s) as the applicants would supposed to possess certificates from different recognized boards where scoring procedure is different to one another and also this would ensure normalization in calculation of marks as well as parity among different academic boards.

D. MODE OF APPLICATION:

1. Candidates should submit application through Online mode only via the following URL <https://opportunity.maldadistrict.in/> then click to "ASHA Online Application System, Sadar Subdivision" available at recruitment TAB at www.malda.gov.in.
2. The application window will be activated from 16.01.2026 from 5:00 PM upto 27.01.2026 11:59 PM.
3. One candidate is allowed to submit only one application. More than one application, if submitted by the same candidate, no application(s) will be entertained.
4. Candidate may collect information and assistance in filling of the Application Form from their respective Health Sub Centers / BPHC/RH.

E. ORIGINAL DOCUMENTS TO BE REQUIRED AT THE TIME OF INTERVIEW (Photo copy with self-attestation):

1. Voter's Card
 2. Admit Card of Madhyamik Examination
 3. Marksheet of Madhyamaik Examination
 4. Caste Certificate
 5. Experience certificate, in case of Grade-I & Grade-II SHG members/trained dais/Link workers.
- ❖ Selection is based on marks obtained by the candidates in the Madhyamik/ equivalent examination (90% weightage would be given on the marks obtained without additional/optional/elective subject(s) in the Madhyamik or equivalent Examination)

❖ Score in the interview (10% weightage)

Preference would be given to the SC/ST and Grade-I/ Grade-II SHG members and Trained Dais and Linked Workers according to the prescribed guidelines as cited before. This preference implies that priority of an applicant over other(s) if two/more than two applicants get the same score after final tabulation. Preference for SC/ST indicates age relaxation according to afore mentioned ASHA recruitment guidelines and also priority for an applicant for such service village where SC/ST concentration of population is higher than Unreserved population. As there is no mention of OBC in ASHA recruitment guidelines so there would not be any preference in this category. The certification of these aforesaid qualifications should be obtained from competent authorities like SDO/BDO/BMOH where it deems appropriate.

F. GENERAL CONDITIONS:

1. Candidates, before applying, should carefully read the instructions and ensure fulfilment of the eligible criteria at the time of submission of application.
2. Submission of application does not guarantee an appointment.
3. Candidates shall be disqualified at any time and at any stage during the selection process, in case of any misrepresentation of facts and documents. Appropriate legal action will be taken against such candidate.
4. Sadar Sub Divisional Level ASHA Selection Committee, Malda reserves the right to alter the modes of examinations or conduct, re-interview or cancel part or whole of any process of recruitment at any stage, if required.
