- 2) Applications without the prescribed fee would not be considered and would be summarily rejected. No representation against such rejection would be entertained.

## INSTRUCTIONS & INFORMATION

- 1) The candidates must have a valid email id and mobile number through which he/she will get registered with the online application portal.
- 2) Minimum Essential Qualification:
  - i) For the department of Assamese, Economics, English, Political Science, Sociology, Chemistry, Physics & Mathematics.

### A. Professor :

#### Eligibility:

- i. An eminent scholar having a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer-reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2
- ii. A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and/or research experience at equivalent level at the University/National Level Institutions with evidence of having successfully guided doctoral candidate.

OR

An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not induced in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience.

## B. Associate Professor:

### Eligibility:

- i) A good academic record, with a Ph.D. Degree in the concerned/allied/relevant disciplines
- ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point-scale, wherever the grading system is followed).
- iii) A minimum of eight years of experience of teaching and/or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2.

## C. Assistant Professor

### Eligibility:

- i) A Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the grading system is followed) in a concerned/relevant/allied subject from an Indian University, or an equivalent degree from an accredited foreign university.
- ii) Besides fulfilling the above qualifications, the candidate must have deared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulations 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:
- iii) Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Bye-laws/Regulations of the institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for or equivalent positions in recruitment and appointment of Assistant Professor Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-
  - a) The Ph.D. degree of the candidate has been awarded in a regular mode.
  - b) The Ph.D. thesis has been evaluated by at least two external examiners.
  - c) An open Ph.D. viva voce of the candidate has been conducted.
  - d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal.

- e) The candidate has presented at least two papers based on his/her Ph.D work in conferences/seminars sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfilment of these conditions is to be certified by the Registrar or the Dean (Academic Affairs) of the University concerned

**Note:**

NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

OR

The Ph.D degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following (1) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University (Shanghai).

**Note:**

The Academic score as specified in Appendix II (Table 3A), shall be considered for short-listing of the candidates for interview only, and the selections shall be based only on the performance in the presentation/interview.

**ii) For the department of Computer Science and Engineering.**

**A. Professor**

**Eligibility:**

- i. Ph. D. degree in relevant field and First class or equivalent at either Bachelor's or Master's level in the relevant branch.

AND

- ii. Minimum of 10 years of experience in teaching/research/industry out of which at least 3 years shall be at a post equivalent to that of an Associate Professor.

AND

- iii. At least 6 research publications at the level of Associate Professor in SCI journals/UGC/AICTE approved list of journals and at least 2 successful Ph.D. guided as Supervisor/Co-supervisor till the date of eligibility of promotion.

OR

At least 10 research publications at the level of Associate Professor in SCI journals/UGC/AICTE approved list of journals till the date of eligibility of promotion.

iii) Qualifications are as per UGC/AICTE regulations/Govt. of Assam order, if any, shall be applicable and upto date amendment of said regulations/order.

5) After submission of the ONLINE application in the portal a duly signed hard copy (pdf) of the completed application(s) must be submitted to The Registrar, Birangana Sati Sadhani Rajyik Vishwavidyalaya, Golaghat Engineering College Campus, Golaghat, Assam – 785702 along with all necessary enclosures including the proof of submission of application fee and "No Objection Certificate (NOC)", wherever applicable, by the last date. 6) Non receipt of Hard Copy of application along with the required enclosures may lead to rejection of approval form.

7) Applicants must submit a copy of the e-generated receipt of the payment along with the hard copy of the application.

8) Duly signed hard copy of online application for each post must be placed in SEPARATE COVER with the name of the post and name of the Department clearly super-scribed on the envelope. The University shall not be responsible for any misplacement, omission etc. if two or more applications are put in one cover by any candidate. Candidates should submit the application in the prescribed format along with the necessary enclosures as mentioned above.

9) Candidates are advised not to enclose copies of papers, which have been submitted but have not yet been published or have not been accepted for publication. These will not be entertained.

10) Maximum age limit, if any and qualifications will be taken into account as on the closing date mentioned for receipt of applications.

11) Application(s) received after the last date or incomplete in any form or without the application fee shall be summarily rejected. Those in employment must submit 'No Objection Certificate' from the concerned employer. However, one may send a copy of the application as "ADVANCE COPY" within the closing date. In such a case, the "NOC" should be produced by the candidates before the interview.

- 12) Any changes/amendments/updates shall be posted in the University website: [www.bssrv.ac.in](http://www.bssrv.ac.in). Candidates are advised to check the University website for such updates.
- 13) Those who are in employment should submit their applications through proper channel or must submit a No Objection Certificate from the employer.
- 14) Self-attested copies of Mark-Sheets, Birth Certificate, Educational Certificates and Experience Certificates etc. must be attached to the application. Incomplete applications or applications without relevant enclosures will be outrightly rejected.
- 15) The University reserves the right to withdraw any advertised post at any time without assigning any reason thereof. The right is also reserved with the University either to fill or not to fill the post and its decision in this regard shall be final.
- 16) Field with STAR (\*) mark are mandatory and essential to be filled in by the candidates. After the required information has been provided, click submit button. However, before clicking "Submit" button, candidate must make sure that no changes are required and the information provided is correct and final. After the application is submitted, no changes will be entertained.
- 17) The candidate should meet the eligibility criteria and provide the information which he/she possesses as on the last date of submission of the application. Candidates who do not possess the requisite educational qualification as on the closing date of receipt of application will not be eligible.
- 18) Candidates belonging to SC/ST(P)/ST(H)/OBC/PWD category should submit the prescribed certificate as per the proforma of the Government of Assam.
- 19) Mere fulfilling the conditions does not guarantee that the applicant will be shortlisted for interview. The university has a right to decide the mode of screening and testing the applicant for shortlisting and selection. Moreover, the University also reserves the right to set additional criteria for shortlisting the candidates. The application should, therefore, furnish full details of qualification and experience passed in the relevant fields, over and above the minimum prescribed. Documentary evidences will be verified during the selection process.
- 20) The University reserves the right to revise/reschedule/cancel/suspend/withdraw the recruitment process without assigning any reason. The decision of the University shall be final and no appeal in this regard shall be entertained.
- 21) The registration will be provisional as the eligibility of the shortlisted candidate will be verified at the time of Interview from the original documents. Candidature of a registered candidate is liable to be rejected at any stage of recruitment process or even after joining, if any information provided by the candidate is found to be false or not in conformity with the eligibility criteria.
- 22) Canvassing in any manner would entail this qualification of the candidate.
- 23) The applicant will be responsible for the authenticity of submitted information of documents and photographs.
